The European Climate, Infrastructure and Environment Executive Agency (hereinafter referred to as “the Agency”), acting under powers delegated by the European Commission (hereinafter referred to as “the Commission”), and represented for the purposes of signature of this amendment by **Angelo SALSI**, Head of Unit, or his duly authorised representative,

WHEREAS

(1) The grant agreement No **LIFE16 NAT/FR/000593**, hereinafter referred to as “the grant agreement”, entered into force on 07/06/2017,

(2) The coordinating beneficiary approved on June 14, 2022, the transformation of the Joint Syndicate "Regional Agency for the Environment - Regional Agency for Biodiversity" (ARPE-ARB) into a public establishment for environmental cooperation "Regional Agency for Biodiversity and the Environment Provence-Alpes-Côte d'Azur" (ARBE) as of January 1, 2023

(3) The coordinating beneficiary has the mandates of all associated beneficiaries participating in the grant agreement for the purpose of the signature of this amendment.

Have agreed as follows:

Article 1

The grant agreement **LIFE16 NAT/FR/000593** (hereinafter referred to as "the grant agreement") is modified as follows:

(1) Forms A1, A2, A4, C2, C3 and FC, as set out in Annex II of the grant agreement are amended as set out in the new forms A1, A2, A4, C2, C3 and FC, as attached.

(2) The coordinating beneficiary deliberated on June 14, 2022 and approved the transformation of the Syndicat mixte « Agence régionale pour l'environnement – Agence régionale de la Biodiversité » (ARPE-ARB) en établissement public de coopération environnementale « Agence régionale de la biodiversité et de l'environnement Provence-Alpes-Côte d'Azur » (ARBE) on January 1, 2023) and consequently approved the substitution of the Public Establishment for Environmental Cooperation, on the day of its creation, in the of the rights and obligations of the Syndicat mixte and the taking over of all of the goods and personnel of the latter by the Establishment and empowered Madam President to notify the Prefect of the Region of the deliberation so that the latter decides on the creation of the Public Establishment for Environmental Cooperation on January 1, 2023 and to mandate it to carry out all the procedures and formalities relating to the implementation of this transformation approved by the decision of the Syndicate Committee of June 14, 2022.) In order to integrate the administrative deadlines necessary for the recovery of all property and personnel by the Public Establishment for Environmental Cooperation, following the transformation on January 1, 2023, a 6-month extension of the expiry date of the Grant consent is required. The project deadline is therefore changed to June 30, 2023.

Article 2

With the exception of the modifications introduced by the present amendment, all other provisions of the grant agreement, as amended by letter amendment No 1 and 2 remain in full force. This amendment No 3 forms an integral part of the grant agreement.

Article 3

This amendment will enter into force on the day of the last signature of the parties to the grant agreement.
